- 1. All applicants wishing to sell food must be licensed as Temporary Food Stall vendors with their local Victorian council and hold a current Registration of Food Premises.
- 2. All applicants wishing to sell alcohol must hold the appropriate VCGLR wine and beer licences. Open containers cannot be sold on the marketplace.
- 3. Copies of these registration certificates must be submitted with this application.
- 4. Applications will not be processed until these certificates are received.

Payment for site fees

- 1. Cost of a site is \$70 per day.
- 2. Site size is 3m x 3m with a limited number of double site bookings (6m x 3m) only available if numbers permit.
- 3. All stall fees must be paid for by 1st February 2024 once notification of a site has been given.
- 4. Cancellations prior to the 1st March will be given a refund or credit
- 5. After 1st March, no refunds or credits will be given.
- 6. Payments can be paid by direct credit, credit card (over the phone or in person) or cash (in person)
- 7. Bank Details will be given on approval of application and confirmation of site booked.
